President's Message By Henry Jordan



First, let me wish you all a Happy Thanksgiving in advance. I hope you can enjoy the holiday with family and friends.

Thank you for coming to the 22nd annual meeting of the VPE Council of Unit Owners. Richard Boker, our long-time board member, retired from the VPE Board. We all want to thank him for his many years of service to our association. You have elected Sally Dunford to take his place for a three-year term and a big thank you for approving the revised bylaws which modernize the rules that govern our condominium association. Mike Baum was also reelected to the VPE Board for a three-year term. The VPE officers for next year are Henry Jordan President, Ann Ferren Vice President, Sid Sussan Treasurer and Mike Baum as Secretary.

Our budget has been formulated for 2025 and was sent to all unit owners for review and comment. This past month two budget meetings were held to hear comments on the proposed 2025 budget prior to approving the final budget for 2025. On behalf of the unit owners, I would like to thank both the Budget and Finance Committee, Cris Juarez, and the Treasurer for an excellent job in looking at our projected income status and the obligations in maintaining the wellbeing of the building in developing the budget for next year.

We are all aware of the potential for disasters, both of property and our bank accounts, resulting from water leaks of all kinds. If the water leak is detected early, little damage will incur to your unit and with the neighbors' units. Unfortunately, we do get leaks in the building caused by just things happening. It is too late when you discover the water on the floor as it usually only starts with just a small drip or two.

One way to discover these problems before they become a big problem is to purchase a water alarm. It is a small box that sits on the floor under the sink, behind the refrigerator, in the laundry room and in the bathroom.

It is so sensitive to water that if you just put your hand across the contacts, it makes a loud noise. We urge you to protect you and your neighbors from water damage by purchasing a water alarm.

They cost about \$12 and another dollar or two for a five-year battery. Check with the VPE office staff as they may have some for sale.

It is November and winter is almost in the air. If you are a snowbird about to head south, have a safe journey and we will see you in the spring. If you are driving and have a garage space open, let the office know as there are individuals who would like to rent your garage space. If you are leaving your car outside for the winter, please park on the side of the building near the Overlook and NOT in the snow dumping area.

Again, let me wish you all a Happy Thanksgiving and enjoy the fall weather before we have the cold winter upon us.

Budget & Finance CommitteeBy Doug Carlson

The Budget & Finance Committee, in collaboration with VPE's Property Manager (Cris Juarez) and Treasurer (Sid Sussan), completed a review of the Draft 2025 VPE Budget and forwarded it to the VPE Board for consideration. The Board approved distributing this Draft Budget to the unit owners for their review and comments (written comments can be submitted until October 30th per the October 1st letter from the Treasurer to all unit owners concerning the Draft Budget). Subsequently, two budget forums were held where a total of about 50 unit owners were given a presentation on the Draft Budget and were able to ask questions about details of the Budget and budget process for 2025. It was noted that the total assessments for the 2023-2025 period, assuming the current Draft Budget is approved, track very closely to the Multi-Year Funding Plan that was developed and published in 2022. Attendees were also briefed on some of the yet unknown aspects of current and future projects that may impact budgets in 2026 and beyond.

The next planned step in the budget process is for the Board to meet in late October to consider any new information that might have been gathered, make changes to the Draft Budget, if any are needed, and then approve the 2025 VPE Budget.

Building and Grounds Committee

Some of the language has been simplified and updated. Newer provisions including rental restrictions and insurance requirements have been integrated. If the Council of Unit Owners votes to approve the Amended and Restated Bylaws, the Covenants Committee will turn its attention of updating the Residents Manual including the Rules and Regulations for VPE.

When Is It Noise?

The cacophony of the Bronx is music when you're in the right mood. Certainly, I missed it when I first moved to Leisure World.

In my old apartment there were so many noises: the sound of steam rising in the old radiators. the whistling kettle, thYTTTTTTTTTTTTTT.

The door slamming no matter how many times you said "Don't!"

On the street, the sounds of buses zipping up and down Bainbridge Avenue, the sirens from the ambulances heading for the two emergency rooms just blocks away. There were the sounds of the people, the children shouting and laughing in the playground across the street. And the fascinating mixture of language --- so many languages over the years – Yiddish, Spanish (in all its myriad varieties) Tagalog, Bengali, Chinese, Albanian, and so many more. From the building, neighbors calling out of windows, and kids yelling up from the courtyard.

At work, the phone rang incessantly as did the doorbell. And there were sadder sounds: worried, scared sounds – sometimes tears. And often more cheerful voices of folks who had some hope.



Leisure World is so much quieter. Occasionally we hear the vacuum cleaner in the hallway. Sometimes there's the sounds of the landscaping or maintenance crews. And when the wind is high, we hear it whistle as it comes by our windows. And of course there are still ambulances. But mostly it's just quiet, and I turn on the TV for company.

The sound of my Bronx neighborhood was more incessant, more guttural. There was the constant reassurance that life was passing by just outside the window, from person to person and generation to generation. It was my background music for years —and I still sometimes miss it.

They are Among Us

No, this is not a sci-fi horror story but an introduction to an invasive insect called the **Spotted Lanternfly** that is now among us here in Leisure World and surrounding Montgomery County. First you should know: it is not toxic and does not bite or sting people, but can be a nuisance while flitting about.

It does attack trees and plants especially the Tree of Heaven, its natural food source, maples, and grape vines. It was first detected in Pennsylvania in 2014 and in Maryland in 2018. I first became aware of it while traveling through New Jersey. So, imagine my surprise when one appeared recently on the window ledge outside my condo here. It escaped but not before I photographed it, which turned out to be important. I looked at the Maryland Department of Agriculture website for info. I found a lot of information. It encourages any sighting be reported after photographing it. Without equivocation, the next piece of advice is to kill it. My wife and I also found one on the sidewalk at Leisure World Plaza, which we photographed and squashed. If you see one, kill it, as well as wiping away any egg cluster, if you can, which may look like a splash of mud on trees, walls, ledges, trailers, and vehicles until a good frost.

The Department of Agriculture would like you to kill them but not use pesticides as they are resistant, and pesticides may harm "good" insects. Below are some photos of how they look: gray and spotted with red if their wings spread.

Many of us have difficulty remembering names and faces, or names that go with faces, or faces that go with names. My husband can remember faces, but not their names. I can come up with names, but I don't recognize faces! I read about a condition called "face blindness" some time ago. I figured out that I must have a case of partial face blindness. Recently, I came across an article by Sadie Dingfelder. In it, she describes the neurological disorder called prosopagnosia—or face blindness! The man who coined the term "faceblindness" is Bill Choisser, who asked his partner "Why do TV shows have so many closeups of actors' faces? How are we supposed to tell them apart if we can't see their clothes?" A eureka moment! Sadie describes growing up, hitting it off with somebody and the next day seeing them as a stranger. She learned to cope by the sound of a voice, and treating everybody as a friend. More research followed, resulting in her first book: Do I know you? A Faceblind Reporter's Journey into the Science of Sight, Memory, and Imagination. It's available on Amazon, and the Montgomery County library system has a handful of copies.

So, here's my confession: I have a case of partial face blindness. I've been coping by saying things like "Sorry, I'm blocking on your name. Please tell me again." Please understand, I may not be the only one around that has this problem. Once we meet, I won't recognize you until we meet 6 or 8 more times.

Here, I offer you two faces: Sadie, the author, and Sadie, our youngest granddaughter! (And yes, even I can tell

them apart!)





Addendum:

Since I first drafted this article, I got hold of the actual book. It's fascinating!! Sadie Dingfelder has been a science writer all along; she wrote for the Washington Post. She put herself through a lot of testing to find out if she is really faceblind, and then went on to call up various prominent scientists to be tested on whatever they were working on. She makes the complicated stuff clear, and even writes with chuckles. Here's one: I'm the best of the worst—after a test result. And a quote from Steve Wozniak: I know a company that can build a brain—it takes nine months. It turns out that many of us have some variety (varieties!) of neurodivergence, and get through life ok. But the take home message is that we're all quite different, in various corners of our brains. I highly encourage everyone to consider this, and of course, be kind to each other.

- AMD Mechanical Contractors proposal #6773 to disconnect and reconnect eight residential HVAC units on the 10th tier for roof modifications at a cost of \$12,440.00. Funds to come from Replacement Reserves Account.
- AMD Mechanical Contractors proposal #6774 for a crane rental to relocate the generator and haul away the central rooftop unit at a cost does not exceed \$12,000.00. Funds to come from Replacement Reserves Account.
- 2025 Draft Budget as presented for distribution to unit owners for a 30-day review period.
- To hold two Budget Forums on Tuesday, October 15th at 2:00 p.m. and 7:30 p.m. in the Community Room.
- Rees Broome's proposal to report the required information to the Financial Crimes Enforcement Network per the Corporate Transparency Act at a cost of \$375.
- To go into Executive session immediately following the Board meeting to discuss personnel and legal matters. A roll call was held and recorded with each board member present. All members present voted in favor to go into closed session in accordance with Section 11-109.1 of the Maryland Condominium Act.
